- Completed and signed Wisconsin Temporary Event Operator and Seller Information Form.
- A \$100.00 check for each 10' x 10' booth, made payable to **Ephraim Business Council**, which includes the necessary fee for filing each applicant's Transient Merchant Registration Form with the Village of Ephraim. The entire fee is non-refundable upon acceptance into the Festival.

Door County vendors are eligible for a 75% discount, and may submit payment of \$25.00. All discounted applications are subject for review.

## **SPACE & SET UP:**

1. Each vending space is 10 feet x 10 feet. Please make a note on this application if you would prefer a larger space, and include all additional fees.
2. Each vendor is to provide his or her own display and shelters appropriate for outdoor festivals.
3. Spaces will be assigned by the Fyr Bal Festival Planning Committee. You will be notified of your location at least one week prior. Set up time is anytime after 4pm on Friday, June 16.
4. Vending hours are 11am-8pm, without exception.
5. Vendor parking will be provided at nearby Ephraim Moravian Church to allow festival-goers ample parking.
6. Please teardown in a timely and orderly manner. Leave vending area free of trash and other debris.
7. Fyr Bal is a family-oriented event. No weapons are allowed on Village grounds with or without a permit. All vendors are to conduct themselves in a positive, respectful manner, and avoid strong language and profanity.
